The program utilizes large group buying power to negotiate favorable cost savings on group insurance products, many at discounted premiums. The program features coverages made available through well-known carriers as a part of the *MemberCare Alliance* program. Here's what's available:

Group Health Insurance (underwritten by *Blue Cross Blue Shield of Georgia*)

- 3-5% premium discounts for Chamber-member businesses with 2-50 employees located within designated areas.
- Innovative PPO, POS and HMO products.

Group and Voluntary Dental Insurance

- **Companion Life Insurance Company** offers group dental plans that give you the option of going to any dentist you choose and provides a 5% premium discount. They also offer a voluntary group dental plan.
- **Blue Cross Blue Shield of Georgia (BCBSGa)** offers group dental plans that give you the option of going to any dentist you choose. Although there is no premium discount, you will save money by going to a dentist contracted with BCBSGa.
- **Shenandoah Life Insurance Company** offers a 5% premium discount on group dental plans for Chamber-member businesses with 10 or more enrolled employees.

Group and Voluntary Term Life Insurance

- **Greater Georgia Life Insurance Company** offers group and voluntary term life insurance, with a 10% premium discount on the group product.
